Existing wood windows in three locations on the house that are in deteriorated condition will be replaced with matching wood windows from Sierra Pacific. Original wood windows are one-over-one and the new windows will match.

Cracked mortar at the curved quartzite porch has created moisture issues. To repair, the contractor will remove and reinstall the quartzite with new mortar that will match the original color and bead joint. Walter Ree Masonry is the subcontractor on the project.

Member Halbach made the motion that the work as presented would have a non-adverse effect on the Cathedral Historic District. Member Pfeil seconded the motion with the motion passed unanimously.
